DIRECTIONS TO WOODWARD FARM:

From I-24 NORTH:

Take Exit 81A/US 231 South toward Shelbyville for 24 miles. (US 231 will make a couple of turns through Shelbyville.)
Turn Right on TN 64 for 15 miles
Turn Right on Hunter Road for 1.5 miles
Bear Right at the fork onto Palmetto Cemetery Road
1st house on the left.

From I-24 SOUTH:

Take exit 97/TN 64 turning Left at the bottom of the ramp toward Shelbyville for 15 miles.
Turn Right on 41A for 3.5 miles
Turn Left on US 231 South (follow 231 South through Shelbyville)
Turn Right on TN 64 for 15 miles
Turn Right on Hunter Road for 1.5 miles
Bear Right at the fork onto Palmetto Cemetery Road

Reminder: Hotel grounds are an extension of event grounds – in addition to respecting the property, exhibitors are responsible for cleaning up after their dogs on motel grounds. The actions of exhibitors who hinder the future use of such facilities are subject to disciplinary action by the Test Committee.

NOTICE TO EXHIBITORS:

- In the event of extreme weather conditions, the event may be canceled.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.
- No entry will be refunded if the trial cannot be opened or completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of public enemy, or any other cause beyond the control of the organizing committee.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dog and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the test site. In such case, no refund of any fees will be made.
- Exhibitors are responsible for complete, accurate, and legible information on their entry forms; illegible or incomplete entries cannot be entered into the show. All entries must be made on Official AKC Entry Forms or copies and **must include the Agreement and Rules** and a CERTIFICATION slip must be attached for all TD entries. No Entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.
- **Bitches in season will be allowed to run in accordance with Chapter 2, Section 8 of the AKC Tracking Regulations.**
- All dogs must be on leash at all times. The owner or handler of each dog is solely responsible for having it ready when it is time for its track.
- Exhibitors are responsible for cleaning up after their own dogs. **Please** help us keep this site clean for future use.
- Returned checks do not constitute a valid entry fee. The Test Secretary will add a collection fee as assessed by the bank to the amount of each returned check. Subsequent returned checks from the same exhibitor may result in their being put on a cash only basis.
- An AKC recording fee is included in the entry fee.
- Entries will be shredded for alternates who do not run and entrants replaced by an alternate within 7 days of the test.

THE DRAWING FOR TDX TRACK RUNNING ORDER SHALL BE HELD AT 10:00 A.M. CENTRAL TIME ON 11/24/2019 AND THE FIRST TRACK WILL BE RUN AS SOON AS POSSIBLE AFTER THAT.

In the event an entrant is absent on the day of the test, it shall be the responsibility of the Secretary to determine if alternates are present and whether such alternates shall participate in the test.

INSTRUCTIONS

- 1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
