Any stake with fewer than four entries may be canceled.

This Trial is being run under the **flexible format** option and the club reserves the right to rearrange the running order of the stakes and add/rearrange judges if the size of the trial cannot be efficiently accommodated in available daylight hours by the plan stated in the premium. Stakes with fewer than 4 entries may be canceled, and fees returned.

Directions To Grounds - 381 OLD JONES MILL ROAD, LA VERGNE, TN 36086

From Hwy 24: Take Sam Ridley Parkway east past the business district, and after going through the light at Motlow College (Lt) & Mason Tucker (rt), move into the right lane and exit to Hwy 41, circling and continuing to the right toward La Vergne. Take a right at the second light onto Fergus Rd. (Exxon Tiger Market on the corner).

Go approximately 0.8 miles and turn right onto Jones Mill Rd. Go approx. 1.8 miles and turn left onto Old Jones Mill Rd. The clubhouse and parking lot will be on your left after the road turns to gravel.

If you come in from the North on Hwy 41, you will turn left on Fergus Rd and continue as above.

GSPCMTN offers a standard AKC Rosette to all placed dogs in all stakes.

All participants and spectators are required to wear **blaze orange** in gunning situations.

AKC approved tracking collars are permitted.

ROADING BEHIND THE GALLERY WILL NOT BE PERMITTED.
