**Directions to grounds**

From I. 24: Take Sam Ridley Parkway east past business district and after going through the light at Motlow College (Lt) & Mason Tucker (rt) move into the right lane and exit to Hwy 41 circling around and continuing on to the right toward La Vergne. Take a right at the second light onto Fergus Rd. (Exon Tiger Market on the corner). Go approximately 0.8 miles and turn right onto Jones Mill Rd., Go approx. 1.8 miles and turn left onto Old Jones Mill Rd. Follow signs for the Field Trial grounds. Go left down the road to the club house, barns and kennels. If you come in from the North on Hwy 41 you will turn left on Fergus Rd and then continue as above.
